NOTICE INVITING TENDERS (INTERNATIONAL COMPETITIVE BIDDING)

Sealed bids on lumpsum basis for Power Transformers, Stations Transformers and Unit Auxiliary Transformers are invited on behalf of Blue Energy Limited for Super Trishuli Hydropower Project (100 MW) hereinafter referred to as "the Employer" from eligible Firms under International Competitive Bidding (ICB) process by the Employer for Design, Manufacture, Supply and Delivery to Site, Erection, Testing and Commissioning of the following package:

 Completion Time:
 The date of completion i.e successful testing and commissioning of Transformers in Aug 2026.

1. Qualifying Requirements

The invitation to bid is open only to eligible parties who meet the qualifying requirements for the Facilities set forth in the following paras, as a minimum. The Bidders who are not manufacturers but have experience in supplying installation, testing and commissioning of transformers will also be eligible to bid in association with manufacturers, provided that all the essential qualification criteria set forth under clause 2 (for their part) are fulfilled by such Company and the manufacturer(s) proposed to be associated by it for supply of the equipment (for complete scope).

One manufacturer shall be allowed to associate with one bidder as associate in such case.

2. Technical Criteria:

(a) General Experience

If bidder is a Manufacturer, it must have designed, manufactured, supplied, erected,

and commissioned 220 kV or above three phase power transformers for a sum total of at least NPR 50 crores (In words Nepalese Rupees Fifty Crores Only) in preceding -five (5) years.

Or

If bidder is a Supplier, it must have supplied, delivered, erected and commissioned three phase power transformers of 132 kV or above for a sum total of at least NPR 25 crore (In words Nepalese Rupees Twenty Five Crores Only) in preceding -five (5) years and shall associate with Manufacturer, who has designed, manufactured, supplied, erected, and commissioned 220 kV or above three phase power transformers for a sum total of at least NPR 50 crores (In words Nepalese Rupees Fifty Crores Only) in preceding -five (5) years

(b) Specific Technical Experience

If bidder is a manufacturer, it must have proven experience in design, manufacture, supply, erection, and commissioning of minimum 4 nos. of Power transformers (total) at two different projects having rating of 30 MVA or higher and voltage level 220 kV or higher in the last 5 years and should have been in successful operation for at least last 2 years.

Or

If a bidder is a supplier, it must have proven experience in supply, erection and commissioning of minimum 4 nos. of Power transformers or transformer banks from at least two different projects having rating of 20 MVA or higher and voltage level of 132 kV or higher in the last 5 years which should have been in successful operation for at least last 2 years. Bidder shall associate with manufacturer who has experienced in design, manufacture, supply, erection, and commissioning of minimum 4 nos. of Power transformers at two different projects having rating of 30 MVA or higher and voltage level 220 kV or higher in the last 5 years which should have been in successful operation for at least last 2 years.

The bidder has to furnish letter of authorization in the prescribed format provided in Bid forms from the proposed associated manufactures duly signed by their authorized signatory.

Financial Criteria

The average annual turnover of the Tenderer in the preceding three (3) completed financial years as on the date of bid opening shall not be less than NPR 25 Crores and must have a positive Net Worth.

3. Clarifications required by the Bidders.

4. Site Visit

A site visit by the representative(s) of the Bidder and BEL can be planned by prior information to BEL.

3. Pre-Bid Meeting

A Pre-Bid meeting open to all prospective Bidders will be held Online meeting or in the Office of BEL at Kathmandu, wherein the Bidders shall be given an opportunity to obtain clarifications, if any, regarding the work and Bid conditions. The bidder shall submit the queries upto 18.10.2024. The exact time and date of pre bid meeting shall be intimated separately. Clarifications shall be shared with all potential bidders through email.

4. Submission of Bids

Sealed Bids superscribed "Bid for BEL/PKG- Transformers" shall be submitted in a single cover containing Qualification & Techno-Commercial and Price Bid. If the due date of receipt of Bids as aforesaid is declared holiday, Bids would be received upto 1500 Hrs. on the next working day. Bids received late may be rejected and telegraphic/fax Bids & incomplete Bids will not be entertained.

5. Bid Security

The Bid Security of NPR 25 Lacs (In words Nepalese Rupees Twenty-Five Lacs Only) must accompany each Bid and the Bid not accompanied by the Bid Security shall be rejected as non-responsive.

6. Bid Validity Period

Bid shall be valid for a period of 180 days from the due date of submission of Bid.
